"Every entry at a recognized show shall constitute an agreement and affirmation that the person making it, along with the owner, lessee, trainer, manager, agent, coach, driver, rider and the horse: (1) shall be subject to the Constitution and rules of the Association and the local rules of the show; (2) that every horse, rider and/or driver is eligible as entered; (3) that the owner and any of his representatives are bound by the Constitution and Rules of the NEHC and the show will accept as final decision of the hearing committee on any question arising under said rules and agree to hold the show, the NEHC, their officials, directors and employees harmless of any action taken; (4) that the owner, rider/driver and any of their agents or representatives agree to hold the NEHC, the show and their officials, directors, employees and agents harmless for any injury or loss resulted, directly or indirectly from the negligent acts or omissions of said officials, directors, employees or agents of the NEHC or show"

Management reserves the right to decline or refuse any entry without being liable for compensation, and eliminate from further competition any exhibitor or horse should the best interest in the show be served.
